# Outstanding Recalls for General History and Procedure, Specimen or Sample

Previously when adding a recall, if an outstanding recall existed within a Structured Data Area (SDA), the existing recall status was changed to Complete and a new recall added. The exception to this was when adding recalls which belonged to the General History and Procedure, Specimens and Sample SDA's. Existing recalls for such entries were not updated automatically and had to be manually changed.

From DLM 350, when a recall is entered with Read code which is not mapped to any SDA (mapped to General History by default), it now auto-completes any previous recall with exactly the same code.

## England - EPS Release 2 – Phase 3

#### **Controlled Drugs**

The following changes have been implemented for controlled drugs:

• All users can now see in the Options-Setup screen from the front screen of Vision, if schedule 2 & 3 and private prescribing are enabled for EPS 2. Ministerial approval is needed before this option can be used.

#### View Rejected and Cancel Failed

You can now view **rejected** and **cancel failed** prescriptions from Bulk Signing - Rejections tab. This takes you to the rejected tab in Prescription Manager.

#### Mark Prescriptions as Cancelled

When a prescription has been marked as cancelled, the All Prescription icon for the

user it was assigned to displays as est which means that there are prescriptions that have been cancelled in your list. Previously, the icon display remains as such regardless of the date filter, from DLM 350 you can now mark prescriptions as

cancelled which removes alert **e**! for that patient. Simply right click on the item in the Prescription Manager window.

#### **Cancellation Error Information**

For Cancellation errors, you can now access the cancellation reason, dispenser and dispenser telephone number:

- 1. In Consultation Manager, go to Therapy.
- 2. Display the Prescription Manager screen by pressing F9 or click on .
- 3. Find the prescription you would like to know about using the various filters.
- 4. Right click and select Properties. From here you can see the reason for the prescription cancellation along with the dispenser name and telephone number.

#### **Bulk Signing**

#### **F9 to Sign Prescriptions**

You can now press F9 to sign selected prescription(s) in the workflow list.

#### **Urgent Prescriptions**

Prescriptions marked as urgent are displayed in the bulk signing screen at the top of

the selected patient's prescription items list with the following symbol  ${rac{64}{2}}$  .

#### **Prescriptions Displayed Oldest First**

The order of prescriptions in the patient's prescription items list in the bulk signing screen is ordered oldest prescription first, rather than in alphabetical order. Unless there are urgent prescriptions which are at the top of the list with the following

symbol 💇.

#### Edit Information for Patient/Dispenser

From the bulk signing screen, you can now right click and select **Edit Additional Instructions**. This allows you to change information notes for the patient or dispenser:

- 1. In Consultation Manager, select the Elist All Prescriptions icon (you do not have to have a patient selected to access this screen).
- 2. Click on the **Review Required** tab.
- 3. Select the required patient.
- 4. In the window that displays the prescription items right click.
- 5. Select Edit Additional Instructions.

#### **Reminder - Printing Tokens for Previous Electronic Prescriptions**

To print a barcoded token for prescriptions which have been previously sent as electronic only:

- 1. In Consultation Manager, go to Therapy.
- 2. Display the Prescription Manager screen by pressing F9 or click on .
- 5. Find the prescription you would like to know about using the various filters. And tick the box to select it.
- 3. Now press Print.
- 4. A token is printed and no message is resent. The drug item is now displayed as electronic + token.

## **Creating a WCCG Referral from the Floating Toolbar**

You can trigger WCCG from the floating toolbar referral icon. This speeds up the referring process:

- 1. From **Consultation Manager**, with the patient selected and a consultation open, click and hold on the History entry you wish to refer.
- 2. The floating toolbar is displayed, point to the bowtie icon and release the mouse button, this opens the **Referral Add** screen.

#### **Previous Address and Previous GP**

For both Immigrant and Ex-service Acceptance Types, you now must complete the Previous Address and Previous GP details. To prevent a registration being saved without this information, an \* is displayed to indicate mandatory information.

# **Registration Links Changes**

#### **Re-acceptance**

The previous address and previous GP are now mandatory requirements for Reacceptance transactions within Vision Registration Links.

When a re-acceptance is received from your Trading Partner (TP) following a rejection (this usually indicates the wrong TP was initially selected), and the previous address and/or the previous GP name have not been recorded:

- 1. From Registration Links Incoming Transactions, select Process.
- 2. Click on the transaction that requires re-acceptance and select **Process**.
- 3. Re-acceptance following the receipt of a Rejection is displayed.
- 4. Change the **Responsible TP** as required from the available list.
- 5. Complete the **Previous Address**, if there is a previous entry, this option will be greyed out.
- 6. Complete the **Previous GP name**, if there is a previous entry, this option will be greyed out.

**Tip** – 'Unknown' can be entered where the previous address or previous GP information is not available

- 7. Enter GP Notes if required.
- 8. Click **OK** to save and submit.

# **Pharmacist Prescribing Code**

As per changes to pharmacy regulation, Vision now accepts the new GPhC prescribing numbers which are seven numeric digits starting with a 2 (eg 2123456). You are encouraged to enter this in Control Panel – File Maintenance as prescriptions prescribed by pharmacists with the old number may be rejected by the PPA.

- 1. Go to Control Panel File Maintenance Staff.
- 2. Right click on the pharmacist and click Edit.
- 3. Go the Professional tab and replace the Prescribing code with the new GPhC prescribing number.
- 4. Press OK to save.

# **Options - Install .Net Framework**

For LAN practices, DLM 313 brought .net installation which is needed to run certain Vision functionality ie CVD Risk Calculators. From DLM 350, there is a new selection in the Options menu to Install .Net framework which allows you to view the versions of .net currently installed on the workstation. You can also select Install New Version to check for upgrades.

# **England - Spine Message Failure Notification**

From DLM 350, with Background Queue Monitoring Enabled, you are now warned if your messages are not sent from your Vision system to the Spine (ie if your N3 internet connection is down or there is a problem with your GPC machine).

#### To Enable Background Queue Monitoring

- 1. From the main Vision screen, select **Options Status**.
- 2. Click on the **Options** button.
- 3. Tick Enable background message queue checks.
- 4. Press OK.

#### **Unsent Message Warning**

If you have a problem with your Spine messaging, a system tray alert displays the following:

"There may be a problem with the messaging program. Spine services (PDS,EPS,CAB,etc) are unavailable. You are advised to check the GPC machine. Please also check any EPS prescriptions and take alternative actions as they may have not reached the spine."

Please check that your GPC machine is working properly. When the GPC is working properly, you can then access Mail Manager and reprocess the messages to resend them.



**Note** - It is important you attend to the error message as soon as possible as your patient may be waiting for their EPS prescription at the pharmacy.
