Summary of Changes

The following pages list a summary of changes to Vision functionality in DLM 410.

New Look Vision On-Screen Help

• New Look On-screen Help in Vision – From DLM 410, Vision on-screen help has an improved, more user-friendly look and feel. It also has improved cross-topic navigation and, enhanced search capability. Vision on-screen help is now held on our web server and can be updated directly - and independently of DLM releases. This means a reduction in file volume for DLM downloads. Web analytics will allow us at INPS to know which help files are accessed and how often the help is referred to. There is also future scope for customer feedback.

Consultation Manager

Therapy

- Prescribing Generics and Brands Vision now allows the prescribing of generic preparations which are marked as "not recommended to prescribe brands not bioequivalent" or "not recommended to prescribe - patient training required" in dm+d, only warning users that they are recommended to be prescribed by brand. Items marked as "never valid to prescribe as a generic" by dm+d will still require a user to select a brand.
- **Parallel Imports** Parallel Imports are now hidden from the drug select screen by default. To view Parallel Imports, select the "all Generics" filter on the drug select screen. Parallel Imports are marked with a P and "Parallel Import" is displayed in the drug information screen.
- England EPS Release 2 Preferred Pharmacy and Nomination From DLM 410, if the EPS Nominated Pharmacy is updated by a third party and is different to the Preferred Pharmacy recorded in Vision, an EPS Nomination Mismatch Alert is displayed in the Alerts Pane in Consultation Manager.

Immunisations

• New Flu Vaccination Read Codes – The Read dictionary update Q1 2012 contains new Read codes for recording Seasonal Flu vaccination. The Read Code 65E.. Influenza Vaccination is still present in the dictionary and although still eligible for Seasonal Flu reporting is NOT accepted in the QOF 2012-13 Business Rules.

Tests SDA

• **Prostate specific Antigen** – Prostate Specific Antigen is now in the Serology Structured Data Area (SDA) with new Read codes.





CVD Risk Calculations

- Annual Update There have been some changes to the Read codes used to calculate Framingham, Assign, QRISK and CHADS2
- **Auto-recalculate** When switching between CVD risk calculators the risk percentages are now automatically calculated.

Test Requesting

• **Test Requesting** – Vision now integrates with Plumbtree test requesting systems. See the test requesting user guide <u>here</u>.

General

- Medical History comments font The font used for medical history comments, which was changed in a previous DLM, has been changed to the standard Vision font.
- **Current Consultation Tab** The consultation pane no longer erroneously displays when changing the Vision 3 view.
- **Patient Links Browser Tab** The patient map now links to Google maps.

Search and Reports

- Update to Tab Separated Exports Therapy and dispenser notes are now displayed in the dosage column when exporting therapy data to Excel in Tab Separated format.
- **Miquest** New referral Read code mappings At the request of Primis, referral Read codes and Specialities are now included in Miquest queries.

GP2GP – England

- Docx Attachments Docx attachments can now be exported and imported as part of the GP2GP message.
- Allergy Records From DLM 410, where an allergy record is received from a non-Vision system without an attached drug, it will be imported as a nondegraded allergy record with the Read code 14L..00 H/O: Drug allergy instead of 9bJ..00 Transfer-degraded record entity.
- **Degraded Test Results** Degraded GP2GP pathology messages previously filed as medical history entries. From DLM 410, the messages now file as a test entity with the Read code **677 Other lab result information**.
- Results Outside Reference Range Previously pathology results with a test reference of "outside reference range" where shown with the result qualifier of "None". This has now been updated; "Outside reference range" is now filed as a Result Qualifier and is no longer added to Notes.
- **Pathology Units Change** From 410, when pathology messages with a Units label are imported, they are mapped to the text equivalent.

SCI Gateway Release 1.23

- SCI Gateway has introduced several new message types that integrate with Vision. The new message types are:
 - Advice Request A message you create that enables you to ask advice from consultants.





- **Advice Response** A reply to an advice request.
- Discharge Notification A message notifying you of patient discharge details.
- **Supplementary** A message you can create that acts as an appendage to a pre-existing Advice Request or Referral.

The new messages can be utilised by practices that integrate with: **SCI** – Scottish Care Information, **WCCG** – Welsh Clinical Communications Gateway and **Northern Ireland CCG** – Northern Ireland Clinical Communications Gateway (Northern Irish Practices can only use Supplementary messages at this time).

Additionally, the Ethnic Origin section of a Gateway Referral template is now automatically completed from the information recorded in Vision.

Note – Although these messages are available, please check with your Health Board to see if they are being used in your area.

Northern Ireland

- **Pharmacist Prescribing Number** From DLM 410, for practices in Northern Ireland, Vision now accepts 4 and 5 digit pharmacist prescribing numbers.
- **Emergency Care Summary** Has been updated to include repeat dispensing, and items prescribed outside of the practice in the ECS message.

Mail Manager

MiG (Medical Interoperability Gateway) Messages

- From DLM 410, there is a new MiG Message type called Clinical Correspondence.
- The sending organisation of incoming MiG messages is now displayed in the Audit Trail tab of the message in Mail Manager.
- A MiG Document Delivery message is now sent as soon as the message is received in Mail Manager (previously, this was sent when the message was filed).

Vision Online Services/My Health Online

- Non-Viewable Slot Type Non-viewable slot appointments can now be viewed in Consultation Manager. Patients booked into non - viewable slot appointments will not receive email/SMS notifications.
- **Did Not Attends (DNAs)** A new setup option is available to determine whether patients can view their DNA details.
