QOF v18 Business Rules including v17 changes

QOF Rules v17/v18 business rules

Version 17 - The NHS Information Centre updated the QOF business rules version 17 following the April 2010 code release. NHS Connecting for Health issued the business rules for information only. This allowed GP practice staff to be informed of the latest codes qualifying for the QOF clinical disease areas. It also allowed GP system suppliers and any third-party software suppliers to update relevant QOF local searches and templates where appropriate.

Note that QMAS was not updated to accept business rules version 17 messages from GP system suppliers.

The suite of v17 audits written by INPS showed the Read code changes for each of the affected lines within the audit. These audits WILL NOT report to QMAS. They were visible from the "All Audits and QOF monitoring" tab within Clinical Audit BUT reported to REFERENCEDATE. Hence the results shown are what would be reported if today was 01/04/2011.

V18 Business Rules were released following the October Read code release and incorporated all the v17 rule changes. The v18 ruleset has been used to create a new set of QMAS reporting audits which will be conformed as usual and QMAS will be updated to receive the messages.

This User Guide combines both v17 and v18 changes.

The nGMS Guideline for v18 is available and can be downloaded from the InPS website, together with its User Guide. From the installation of the **v17** guidelines, an ampersand has been added at the beginning of each guideline in the suite, including the embedded ones. If you wish to delete all the nGMS guidelines, for example, prior to importing a new version, just type **&** in the Mnemonic of Select Guideline, and then hit the Delete key rapidly until each guideline has been deleted.
